Who We Are



Our business is grounded in respectful relationships advancing reconciliation in Western Australia. This past year was a landmark year for Reconciliation WA (RWA).

Following a period of generous funding from our corporate partners and members, which we acknowledge have brought Reconciliation WA to where it is today, the Western Australian Government indicated its intention to drive leadership in reconciliation with the commencement of a four-year partnership in June 2019.

With the support from the Department of Premier & Cabinet our future is sustained at an operational level, allowing aspirational and long-term reconciliation initiatives to commence in earnest. We thank the Department of Premier & Cabinet for their commitment, confidence and support.

Two powerful themes aligned this year to engage us all on our shared journey of understanding. National Reconciliation Week (NRW) challenged us to be "Grounded in Truth and Walk together with courage". The NAIDOC theme Voice.Treaty.Truth rallied Australians to embrace the Uluru Statement from the Heart.

With the support of CEDA, AICD, Committee for Perth and many other WA membership bodies, we "raised the bar" on the celebration of National Reconciliation Week. Our annual efforts during NRW remain critical to ensure we all pause, reflect and experience together a powerful reconciliation moment. More than 1,300 people gathered for breakfast at Crown Perth to celebrate a special moment with the newly installed Federal Minister for Indigenous Australians, the Hon Minister Ken Wyatt.

This year has therefore taken RWA to a new place, allowing us to engage with our members, stakeholders and communities across the State regarding our long-term aspirations for Reconciliation.

On behalf of our hard-working Board, we are proud of the efforts and achievements of our small but impactful organisation and wish to publicly thank Mr James Back, our CEO, for his drive and determination to take us to this positive point. As you would be aware, James is moving on after nearly 8 years as our inaugural CEO, and we have the fondest of wishes for him as he moves from strength to strength.

We would also like to extend our thanks to current members for their ongoing contribution to our organisation – without you, we would not be able to carry on our work.

Our passion is high, and our commitment to act as your State's peak reconciliation body has never been stronger. We look forward to working collaboratively and even more powerfully with the State Government, our members, partners and the entire WA community to create a better Western Australia for everyone.

CEO Report

Preparing this year's report has taken me on a wonderful reflective journey over my 7 years at Reconciliation WA. As I hand over the helm, I want to share my highlights from the past year and my aspirations for the future.

It has been an ongoing challenge to deliver long term viability for reconciliation in WA, and this has finally been achieved with the State funding agreement signed in June to secure our financial position for the coming four years. This, along with a sound membership model will ensure our tenure and allows us to look to the horizon with hope and certainty.

During National Reconciliation Week: 'Grounded in truth; Walk together with Courage', we delivered a huge breakfast and were afforded the opportunity to witness Minister Wyatt's moving inaugural address as the First Indigenous Minister for Indigenous Affairs. It fittingly received a standing ovation from 1,300 people in the room. The Annual Walk for Reconciliation followed, where 4,300 people walked into the Heart of the City 'Yagan Square' to stand in unity for a better Western Australia for all.

Place-based reconciliation was a key theme driven through the Yokai Employment Forums hosted this year. People, you – our members and partners, shared your insights, knowledge, attitudes and behaviours to enable others following you to learn and grow. Participants left these sessions challenged, inspired and activated.

What does all this mean for Western Australia? I see better local employment outcomes and stronger teams sharing stories about things they once whispered. This is unifying. This is what I love about our community. I am observing people experience places in a way they have not before, irrespective of colour or creed – celebrating home. I am observing Aboriginal businesses thrive. I am observing businesses working in partnership with Aboriginal businesses thrive. It is my belief that our First Peoples are increasingly successful in business and are doing so in a way that is holistic and patterned to connect back to each other, us and our Country – reinstating balance.

I am excited about the development of cultural frameworks extending into all sectors of the State. We have seen the Kart Koort Warginny inform a number of infrastructure builds in recent years to wonderful effect – Elizabeth Quay, Yagan Square and Scarborough are great examples. The challenge now is for our State's reconciliation community to continue to foster the requisite relationships with our Elders to transfer these learnings to more of our business. I believe that through this we will see both social and environmental outcomes thrive in parallel for a State that truly is better.

As I sit in our newly relocated office at the Constitutional Centre of Western Australia, I am beyond proud of the journey we have travelled together thus far, although I am only too aware of the long road ahead. Our small, yet dedicated Reconciliation WA team are committed to transforming the Centre into a place of truth-telling and the heart of reconciliation projects.

It is with respect and thanks I acknowledge the RWA board and staff for their unwavering commitment, efforts and value in driving our movement.

National Reconciliation Week

National Reconciliation Week (NRW) runs annually each year from 27 May – 3 June. These two dates mark two important milestones in Australia's reconciliation history: The 1967 referendum and the historic Mabo decision, respectively. During NRW, all Australians are invited to reflect on our First Peoples culture, contribution and our shared history.

National Reconciliation Week Breakfast

Reconciliation WA held their annual National Reconciliation Week Breakfast on 13 May providing an opportunity for leaders on Noongar Whadjuk Boodja, to explore the current state of Reconciliation in WA. Nearly 1300 leaders from across the State came together, making it the largest sit down breakfast Crown Perth has ever hosted as well as the second largest Reconciliation Breakfast in the nation.

The Welcome to Country was delivered by Dr Richard Walley OAM, with an inaugural address from the newly appointed Minister Ken Wyatt as Minister for Indigenous Australians. This was a tremendous event promoting collaborative opportunities to advance reconciliation.

Walk for Reconciliation

Currently in its 3rd year and organised by Reconciliation WA, the Walk for Reconciliation is an annual community event built around the theme of NRW. The walk aims to provide a visible and immersive cultural experience that demonstrates commitment to building respectful relationships with Australia’s First People.

The walk concluded in the heart of Perth CBD at Yagan Square, with over 4,300 community members in attendance. Local First Peoples artists, Elders and performers guided community members through a positive celebration of Culture, Country and Connection.

Yokai Employment and Retention Forum

“Yokai” a Noongar word meaning “call to arms and action – to take up the challenge”, is a workshop based around employment and retention, and supply and procurement of First Peoples. This forum was developed to provide a platform for organisations across the Western Australian community to fundamentally challenge their engagement with First People’s, ensuring equitable employment and business opportunities in the workplace.

Now in its 8th year, this Forum functions with a host of organisations sharing lessons learned in Aboriginal employment, retention, supply and procurement. Following the presentations a working session, Yokai Yarning, commences, where groups collaborate and explore different challenges, barriers and successes across different professional sectors.





Leadership in Reconciliation

Following the publication of RA's *State of Reconciliation Report in Australia 2016 (SORA)*, RWA embarked with purpose to discover more constructive and efficient ways to grow the number of people on the reconciliation journey.

The Leadership in Reconciliation Project brings together leaders from across the Western Australian community to explore ways of working towards achieving a reconciled Western Australia. RWA is currently working with leaders from six sectors including Corporate, Community, Education, Government, First People and Young & Emerging Leaders with the intention that:

- Western Australian Leaders support and progress the reconciliation movement.
- RWA provide a pathway for sustainable and practical steps to assist the Western Australian Community to further their reconciliation journey.
- Western Australian Leaders engage to commit and support initiatives to achieve and effect sustainable gains across all Close the Gap targets.

Over the last two years, Reconciliation WA have met with each of the six Leadership Groups, the last two being Education and First Peoples Leadership Groups at the end of 2018. Meeting with all the leadership groups allowed the facilitation of discussion for better understanding of:

- Current community standing;
- Insight into sector engagement and attitudes toward reconciliation;
- Opportunities for cross sector collaboration;
- Significant approaches to accelerate reconciliation through social, cultural and economic opportunities.

Reconciliation is a team endeavour requiring contributions from across all sectors and demographics of the Western Australian community. As the State's Reconciliation Secretariat, RWA has formed strong and sustainable relationships intending to nurture the movement and its momentum; Organising, coordinating and maximising the reconciliation opportunities in Western Australia.

This will unfold in the year ahead as Reconciliation Industry Network Groups (RINGS) in partnership with Reconciliation Australia. We look forward to you participating with us.

Realising Wadjemup: cultural welcome to the island

Wadjemup

In collaboration with Department of Premier and Cabinet, the Rottnest Island Authority (RIA) and the Rottnest Foundation, Reconciliation WA are supporting and promoting the "Realising Wadjemup" vision. This vision aims to respectfully acknowledge and commemorate the use of Wadjemup (Rottnest Island) as a prison for First Peoples all the while honouring the continued connection and spiritual significance of Wadjemup to the Whadjuk Noongar people for over 75,000 years.

The RIA has planned a three-phase approach towards the completion of a permanent memorial, as well as strategies to manage alternative uses of historic sites. The key objectives being to maximise social, cultural and economic development opportunities for our First People.

Reconciliation WA will continue to update the reconciliation community with the progression of the project and seek Reconciliation community resources (financial and in-kind) to assist in the conclusion of the second and third phases of the project in due course.

Social Reinvestment

Social Reinvestment WA (SRWA) is a coalition of not-for-profits, who have a new vision for an effective and connected approach to justice in Western Australia. Co-chaired by Aboriginal and sector leaders Daniel Morrison and Glenda Kickett, Reconciliation WA is proud to have participated and contributed on the executive of SRWA since its inception in 2014.

Within the Australian justice system, WA has the highest percentage of incarcerated Aboriginal people. Despite representing just 3% of our State's population, 78% of children, over half the women and approximately 40% of men make up the prison population. A legacy of inter-generational trauma from the Stolen Generations, systemic discrimination, socio-economic disadvantage, poverty, and inequality has largely contributed to these statistics.

SRWA powerfully advocates for WA to implement Social Reinvestment policies, prioritising strong families, creating safe communities and implementing smart justice.

Growing Participation in Reconciliation

Reconciliation WA is constantly working to increase the number of people actively engaging in the reconciliation movement. We facilitate respectful relationships with our core goals being to enable social, cultural and economic opportunities for First Peoples and the State.



Apology Day

13 February 2019 commemorated Apology Day and the 11th anniversary of the Australian Government's apology. The Apology addressed the families and individuals affected by the State policy that implemented forced removal of Aboriginal children from their families – the Stolen Generation. Research shows that half of Western Australia's Aboriginal community have been directly impacted by these policies, with the distress and desolation still evident in today's society.

On our pathway towards reconciliation, Sorry Day on 26 May is an important moment to remember. On this day we reflect on the sad and painful history of the Stolen Generation and recognise moments of resilience, healing and the power of truth telling.

Reconciliation WA has created a free and available online teaching resource to enable schools across WA to respectfully learn about and commemorate the Stolen Generations.

On May 17th 2019 Reconciliation WA staff joined the West Coast Eagles and their community to activate Optus Stadium for the Indigenous Round in the lead up to National Reconciliation Week. Sharing knowledge and experiences of reconciliation and raising awareness of the theme "Grounded in Truth; Walk together with Courage."

Ideation Workshop

In November 2018 Reconciliation WA, Indigenous Consulting Group and Innovation Central (CISCO) hosted a workshop to explore the following question, "How do we, as Australians, embrace First Peoples culture, traditions and people into our everyday lives?"

In this workshop attendees explored ways to create a sense of pride in our First People's rich cultural history, and how we share that in our homes, our workplaces and our daily to day lives. It examined:

- How we learn about Australia's First Peoples history and contemporary culture;
- How we teach other people in our family or workplace;
- What does embracing First Peoples culture look like, feel like and sound like;
- How do we overcome fear in connecting with, and speaking about First Peoples culture;
- What tools can we develop that may open these doorways and enable people to become engaged in First Peoples culture.

RAP Support

A Reconciliation Action Plan (RAP) is a program that provides a framework running parallel to an organisations business plan, including practical measures to drive involvement in reconciliation. Reconciliation WA has helped over 62 organisations this year, catalysing their commitments to reconciliation through supporting the development and implementation of their organisational RAPs.




