Co-Chair Report

We welcome you to Reconciliation WA's 2021/22 Annual Report.



The reconciliation movement has seen an incredible step change in May, with a commitment by Prime Minister Albanese to implement the Uluru Statement from the Heart in full.

This past year, Reconciliation WA continued to healthily develop and grow its impact and engagement across WA, through a focus on our ability and unwavering determination to support critically important reconciliation initiatives for our State. We are proud to increasingly support our member organisations and their people to achieve reconciliation goals at all stages of their journey, and we strongly advocate that reconciliation is everyone's business.

We were delighted to welcome Nolan Hunter and Meg O'Neill as Board Members at our 2021 Annual General Meeting and were of course pleased to see the re-election of Co-Chair Gary Smith. We farewelled Ezra Jacobs and Hon Fred Chaney AO, who have both contributed so much to the reconciliation movement. We thank them for their strong contribution to Reconciliation WA during their time with us. In particular we were proud to be able to pay special tribute to Fred Chaney's reconciliation legacy through the launch of his Memoirs during National Reconciliation Week 2022.

The 2022 National Reconciliation Week (NRW) program celebrated the theme *Be Brave. Make Change*, and in keeping with that spirit, we strongly developed our NRW programming. With a focus on digitisation and regionalisation, we invited every West Australian to join us for NRW, no matter where they lived or worked. Our Virtual National Reconciliation Week Breakfast saw more than 29,000 individuals and organisations come together online to commit to reconciliation – an incredible jump from our traditional seated breakfast in Boorloo (Perth). We thank everyone who rallied their friends, families, community groups and organisations to participate.

We were incredibly proud to this year launch Reconciliation WA's own inaugural Reflect Reconciliation Action Plan (RAP) during National Reconciliation Week.

We hold ourselves accountable to walk the RAP journey alongside our reconciliation community, not only to measure our existing reconciliation work but to help us experience the RAP journey through first-hand experience. We acknowledge the RAP Working Group, including board members Carolyn Davis and Tim Marney, for their hard work in drafting and championing our first RAP.

We acknowledge the generosity of spirit, culture, and knowledge of the Aboriginal People, communities and organisations who support us and the broader reconciliation movement, and maintain that it is time for the non-Aboriginal community to also recognise the weight of this work, and to "stand up" and carry their fair share. It is only by walking together that we can achieve reconciliation.

We also acknowledge our members and partners who have stood alongside us this year and are committed to the long vision of reconciliation. We were pleased to see a doubling of our membership in twelve months, confirming that our community is prioritising reconciliation.

We end our report with a heartfelt ask. We call on each and every West Australian to read the Uluru Statement from the Heart and to commit to understanding it's potential for lasting and meaningful change in our country.

Our nation is walking ever closer to a pivotal moment in our history: the referendum where we can create the mechanism for our Government to truly listen to First Nations peoples on the issues and policies which affect them. It is an ask that has been made time and time again from Aboriginal People. History is calling, and we implore you to answer whole heartedly.

CEO Report

In the 2022 National Reconciliation Week (NRW) we were asked to Be Brave. Make Change. Across the state, many organisations and sectors stepped up.



The momentum around National Reconciliation Week was significant which saw a new model delivering digital and regional access which we will grow in 2023.

We were delighted with how organisations came to the fore creatively accessing the programs and resources we provided – including the Goldfields Pit Crews 800m underground tuning into the National Reconciliation Week Breakfast – and families, Local Government, State Government teams and others engaging their communities. We champion that NRW should inspire businesses to reignite their focus on reconciliation outcomes for the year ahead.

Our membership in this period doubled, with many people, families and organisations committing to change, to engaging in truth telling and ensuring respectful relationships are being forged with Aboriginal people. There is real momentum, and we commend the efforts of our membership and the community as they prioritise reconciliation education and programs.

We know 2023 will have a paradigm shift with the Prime Minister committing to the implementation of the Uluru Statement from the Heart in full. Reconciliation has been prioritised and has garnered the attention it deserves around the country. In the first term of this government, Australia will be asked to vote to give Aboriginal people a voice on matters that affect them. The reconciliation movement has a genuine responsibility to inform and engage to ensure Australians go to the ballot box with the facts.

I acknowledge all organisations that have formally committed to Reconciliation Action Plans, Statements or are genuinely committed to reconciliation. Often there are challenges, but we promote the mindset of a journey and many now actively engage in our programs from our entry RAP Ready through to focused workshops with our RAP Rings, Reconciliation in Action Forums and Reconciliation Insight Webinars. We are witnessing a maturity in the community and genuine commitment from leadership to make change.

I'm also proud of the impact we are having within education through our partnership with Reconciliation Australia to deliver the Narragunnawali Program, providing rich resources to educators.

We have designed and piloted a new excursion / incursion model this year for primary school children to add a module of learning to the programs delivered at the Constitutional Centre. This has been made possible through our funding partnership with BHP. We look forward to implementing this in full in 2022/23.

We stand alongside a number of organisations driving change – as a supporter of Aboriginal led Danjoo Koorliny, a partner of the Indigenous Emerging Business Forum and a coalition member of Social Reinvestment WA. Collectively we are striving for better outcomes for Aboriginal people based on choice, not chance and walking together.

Many of our programs could not be realised without important partnerships we have with key organisations. Please see page 36 which acknowledges them. We thank them for their genuine support and engagement in the work we are doing.

We acknowledge in particular our partnership with State Government through Department of Premier and Cabinet to enable operational funding and Lotterywest as we realise some important programs.

I also acknowledge and thank the many volunteers who joined forces with us this year – both individual and corporate volunteers – we could not realise our programs without you.

The Australian Reconciliation Network enabled by Reconciliation Australia and other State and Territory Reconciliation partners work on important reconciliation programs. I thank them for the collegiate partnership and look forward to continuing to have impact in the work we do together.

There is no time to rest, the year ahead will continue to build momentum and we will be inviting you all to participate in a very important initiative – Project Respect. Stay tuned for further information.

My thanks must go to the Board and the team. We always frame reconciliation as about hope and responsibility and I'm immensely proud of the work they do to advance the agenda and drive respectful change. A particular thanks goes to the tireless work of our Co-Chairs Gary Smith and Carol Innes.

My final thanks go to the many Aboriginal Elders and Leaders who support the Reconciliation movement on its journey – for their guidance, resilience and kindness – and we hear their challenge to us. It is time.





Our Bidi membership is designed for organisations that are motivated to begin their reconciliation journeys.



Launch of Reflect RAP

During National Reconciliation Week, Reconciliation WA launched our inaugural Reflect Reconciliation Action Plan (RAP).



We found that it was time to walk the RAP journey in partnership with our community, not only to measure our existing reconciliation work but to also allow us to learn more about the RAP journey through first-hand experience.

This RAP reflects our ongoing commitment to reconciliation and builds on the momentum and efforts of years past, as we continue to provide our members, partners and the wider community with key reconciliation services and resources.

We hope not only to broaden our knowledge and understanding of the RAP journey itself, but to also identify any additional reconciliation opportunities that we can adopt, adapt or share with the community.

A dedicated RAP Working Group made up of both Aboriginal and Torres Strait Islander representatives and reconciliation allies, including five RWA employees and two RWA Board members, worked collaboratively to draft the RAP.

The RAP Working Group will be responsible for implementing the plan and ensuring that all deliverables are met and monitored through sound data collection practices.

Weavr collaboration

We have been very proud to partner with Aboriginal business weavr on our journey towards our RAP. The weavr tool is an Aboriginal-designed management system that helps organisations to assign tasks, input data and track measurable actions against the goals of their RAPs or Reconciliation Strategies.

Reconciliation WA and the weavr team collaborated prior to the launch of our RAP, working together to provide the tool at a discounted rate to Reconciliation WA members, so that they can streamline their administration tasks and put more energy into taking reconciliation action.

We were then very eager, of course, to use the weavr system ourselves as we have worked through our RAP actions this year. Reconciliation WA are committed to supporting and extending the reach of Aboriginal businesses across the State.



The Narragunnawali Program

We are pleased to report on another fruitful year of partnering with Reconciliation Australia to support schools and early learning services in Western Australia to act toward reconciliation in the classroom, around the school and with the community.

Reconciliation Australia's Narragunnawali Reconciliation in Education program supports all schools and early learning services in Australia to foster a high level of knowledge and pride in Aboriginal and Torres Strait Islander histories, cultures, and contributions.

The Narragunnawali online platform is free to access and provides practical ways to introduce meaningful reconciliation initiatives in the classroom, around the school and within the community.

Narragunnawali (pronounced narra-gunna-wali) is a word from the language of the Ngunnawal people that means alive, wellbeing, coming together and peace.

Supporting Reconciliation in Western Australian Education

Through the Narragunnawali platform, schools and early learning services can develop a Reconciliation Action Plan (RAP), and teachers and educators can access professional learning and curriculum resources to support the implementation of reconciliation initiatives.

In our third year of delivering the Regional Engagement Program, we continued to see lots of interest from the Early Childhood, Primary School and Senior School sectors, as well as corporate education professionals. Regional Engagement Program (REP) workshops have provided local information, introductions to professional learning and curriculum resources and the Reconciliation Action Plan process, to support whole-schools and service commitment to Reconciliation.

This year our Reconciliation in Education program presented 21 events, workshops and online webinars, engaging more than 1,876 participants, across metropolitan and regional locations to private, government and independent schools, tertiary institutions, and education organisations.

Our state-based Education RING (Reconciliation Industry Network Group) continued to thrive. The RING, which began in February 2020, continues to meet each quarter

with great attendance from a variety of schools and education organisations. Reconciliation WA is committed to delivering the Regional Engagement Program and looks forward to continuing to support reconciliation in Western Australia's education sector.

The Reconciliation through Education Constitutional Centre Program

Work has continued on the Reconciliation Through Education Constitutional Centre Program, a place-based Reconciliation Education Program designed for Year 3 and Year 4 Primary School students.

The program, currently in a pilot stage, creates the opportunity for reconciliation education at the Constitutional Centre of Western Australia (the location of Reconciliation WA's office) in collaboration with the Constitutional Centre and the Electoral Commission.

The program aims to inspire students visiting the Centre to think more deeply about connecting with Culture, to learn about Australia's true history, and to provide foundational reconciliation education. We plan for this program to develop into a meaningful incursion which can be engaged with by schools across WA.

National Reconciliation Week

National Reconciliation Week (NRW) is a time for all Australians to learn about our shared histories, cultures, and achievements, and to explore how each of us can contribute to achieving reconciliation in Australia.

The dates for NRW are the same each year; **27 May to 3 June.**

These dates commemorate two significant milestones in the reconciliation journey – the successful 1967 referendum, and the High Court Mabo decision respectively.

Reconciliation WA works with Reconciliation Australia and the other State reconciliation peak bodies to lead National Reconciliation Week activities in Western Australia. Thousands of workplaces, schools, early learning services, universities, councils, and more also organise their own private or public activities for National Reconciliation Week.

Digital Acknowledgement of Country 27 May 2022

On 27 May 2022, we asked the community to join in for the launch of NRW, to learn about the Traditional Owners of the land they live and work on, and to share an Acknowledgement of Country on their social pages. While we encouraged people to record and share a video of their acknowledgement, we also created a suite of downloadable tiles they could share.

This created an opportunity for a mass demonstration of respect for Traditional Owners and the continuing connection of Aboriginal and Torres Strait Islander peoples to Country.



Be Brave. Make Change

The National Reconciliation Week 2022 theme Be Brave. Make Change. was a challenge to all Australians—individuals, families, communities, organisations and government—to Be Brave and tackle the unfinished business of reconciliation so we can Make Change for the benefit of all Australians.

Reconciliation WA took on that challenge and extended the NRW experience to the entire State.

We set the bar high and aimed to achieve the following:

- Present a Covid-Safe model for NRW 2022.
- Take NRW to community across WA (rather than ask the community to come to us in Perth).
- Ensure regional presence and voices were strong.
- Ensure digital accessibility and inclusiveness.
- We challenged ourselves to Be BRAVE!



NRW Virtual Breakfast 27 May 2022

As a demonstration of our commitment to bringing NRW to the entire state – Reconciliation WA aimed to invite one million West Australians to the NRW Virtual Breakfast, our first time taking the NRW Breakfast wholly online.

From hi-vis in mine sites and story times in classrooms, to families (and fur babies!) in loungerooms and brave conversations in conference rooms - across Western Australia, and the nation, we had people dialling in and committing to brave reconciliation action for the year ahead.

We had strong regional engagement for the NRW Virtual Breakfast, with approximately a quarter of the more than 29,000 registrations coming from outside of the Perth Metropolitan area and participants in every region – and even outside of Western Australia!

The Breakfast featured:

- Four Welcomes to Country from Elders across WA - Uncle Richard Walley, Noongar Boodja; Aunty Dianne Appleby, Yawuru Country; Uncle Derek Councillor, Yamatji Country; and Uncle Aubrey Lynch, Wongatha Country;
- A speech from Hon. Tony Buti MLA Minister for Aboriginal Affairs;
- A moving keynote from Wiradjuri and Kamilaroi man Stan Grant;
- A special segment for school children featuring Karla Hart dancers and a Reconciliation in Education case study from Mosman Park Primary School; and
- A thought provoking Regional Panel featuring Minang Nudgu Elder from the Noongar nation Carol Pettersen from the Great Southern, Nyamal man Danny Brown from the Pilbara, Bardi man Tyrone Garstone from the Kimberley, and Ngalia man Kado Muir from Goldfields-Esperance

Daily Yarning Circles 30 May to 3 June 2022

A Yarning Circle is an important process within Aboriginal and Torres Strait Islander culture, which builds respectful relationships, and allows everyone to be heard. Our 2021 NRW Yarning Circles were our highest rated event, so we continued them in 2022, with the addition of a second online session each day. Co-facilitated by an Aboriginal person and a reconciliation Ally, together the facilitators guided attendees through a yarn on reconciliation, and the NRW theme.

Twice-daily Yarning Circles were held throughout Monday 30 May to Friday 3 June, with an online session held in the morning, and an in-person session at WA Museum Boola Bardip in the afternoon.

The online sessions meant that people from all over WA could tune in to the candid Yarning Circles.

Reconciliation Memoirs with Fred Chaney AO 31 May 2022

The Hon Fred Chaney AO's commitment to social justice, and his belief in the equal value of all people, has driven a long and passionate career in advancing the reconciliation movement in Australia.

We were extremely pleased to launch Reconciliation Memoirs with Fred Chaney, highlighting the achievements, lessons and wisdom of reconciliation leaders. **Walk for Reconciliation
3 June 2022**

Reconciliation WA curated an exciting new format for the Walk for Reconciliation this year, with a focus on Cultural learning and reflection in beautiful boodja (Country) while keeping one another safe.

The Walk took place through Kaarta Koomba (Kings Park), with ten walking waves departing every 20 minutes between 10am and 2pm.

Kaarta Koomba (Kings Park), is a highly significant place to the Whadjuk Noongar people, with its location a key junction of the river and a chain of lakes, all of which are linked by songlines and continuing cultural practices. We invited the community to journey with us through Kaarta Koomba. In spaced sessions, walkers journeyed through the path, with opportunities for learning, reflection and cultural enrichment.

The spaced time slots helped to keep the event COVID-safe, and also helped to protect the Botanic Gardens.

RAP Ready

RAP Ready is Reconciliation WA's free, accessible, in-person and online forum to support organisations commencing or continuing their Reconciliation Action Plan journey.

RAP Ready is a guide for organisations progressing their reconciliation journey, and offers the opportunity to connect with like-minded individuals and organisations in Western Australia's reconciliation community.

The forums are presented by Danny Ford (Kambarang Services) and Tim Muirhead (CSD Network), who both have extensive experience in supporting organisations on RAP Program development. Attendees can expect an introduction to the RAP program, a presentation on progressing through the RAP levels, an organisational case study and a Q&A session.

This year, the Rap Ready program engaged more than 518 participants over 6 sessions. We also heard some great case studies this year from Woodside, Life Without Barriers, Camco Engineering, GESB, RAC Arena. Thank you for sharing your lessons with the reconciliation community!

RAP RINGs

Our RAP RINGs (Reconciliation Industry Network Group) program, free and exclusive to RWA organisation members, builds connected and informed communities of reconciliation peers.

The RAP RINGs connect our members with their reconciliation peers to share case studies and best-practice thinking. Together, the RAP RINGs drive learning, build alliances and enable outcomes across the reconciliation movement. We have two streams of RAP RINGs, one which brings together organisations at their RAP tier level (Reflect / Innovate / Stretch & Elevate), and another which brings together organisations by their sector (Arts & Culture / Sport / Education).

Despite having to pivot some sessions online due to COVID-19, the Rap RINGs program engaged more than 137 participants from our membership, over 6 sessions throughout the year.

A huge shout out to our hosts for the 21/22 RPA RINGs: Keystart, Department of Training and Workforce Development, Curtin University, BHP, HBF, GESB and Woodside.

Exploring Reconciliation Webinars

Our Exploring Reconciliation webinar series provides insight into a range of topical themes in the reconciliation movement and are free for all to attend. We host subject matter experts to unpack complex themes, issues and projects to break down knowledge barriers, and help empower individuals to take action.

We were pleased to engage more than 290 attendees across our Exploring Reconciliation Webinars this year.

WA Government Aboriginal Empowerment Strategy Webinar

In November 2021 we partnered with the Department of Premier and Cabinet to present the WA Government Aboriginal Empowerment Strategy to our reconciliation Community. The session introduced the Strategy's key concepts, principles, strategic directions, and approaches to implementation. It also outlined the relationship between the Strategy and the National Agreement on Closing the Gap, setting out some of the key features of WA's Closing the Gap Implementation Plan.

Uluru Dialogue Webinar

The Uluru Dialogue Webinar in March 2022 brought together a panel of experts to de-mystify the Uluru Statement from the Heart. Pat Anderson AO, Nolan Hunter, Allira Davis and Gordon Cole, together explored the inter-connectedness of the reconciliation movement in Australia, and explained why a First Nations Voice enshrined in the Australian Constitution is critical to the reconciliation movement.

Reconciliation in Action Forums

The Reconciliation in Action Forum series meets 2-4 times a year in Perth. The Forum brings together organisations interested in enhancing the outcomes across Aboriginal workforce recruitment and retention, and supply and procurement.

Through a combination of keynote presentations, panel discussions, breakout workshops and yarning circles, the Forums aim to deliver a supportive and collaborative approach across sectors and industries to the complexities of Closing the Gap and delivering on Reconciliation Action Plan commitments to Aboriginal and Torres Strait Islander peoples.

This year we were pleased to see 208 attendees across our Reconciliation in Action events.

Reconciliation in Action – Innovation in Energy

In November 2021, Western Power, Synergy and Horizon Power partnered with Reconciliation WA to deliver our next Innovation in Energy Forum.

The forum included a CEO panel discussion from WA's energy industry on transformation in reconciliation, with two breakout sessions on supply & Procurement, and recruitment & employment.

Reconciliation in Action – Dual Naming

In March 2022, the Reconciliation in Action Forum explored dual naming. The online forum included a keynote address from Professor Len Collard, Whadjuk Noongar man and Traditional Owner of the Perth area. The forum also included a panel discussion moderated by Monica Kane, with speakers Len Collard, Geri Hayden on the CANWA Walyalup project, Kate Holsgrove on the Perth Airport Traditional Custodians Boarding Gate project, and Denise Gallanagh Wood on the Shire of Katanning Place Names Project.

Following the Forum, we held a unique online workshop facilitated by Professor Len Collard who took participants on a deep dive into Noongar history and place making. A world leader in Traditional Place Naming, Professor Collard will guided attendees through a series of case studies, and then through a practical demonstration of Place Naming.

Social Reinvestment WA

We participate as an Executive Member of Social Reinvestment WA, an Aboriginal-led coalition body comprised of members from the non-profit sector, justice experts, and people with lived experience who work collectively for an effective and connected approach to justice in Western Australia since 2014.

Social Reinvestment WA aim to end the systemic over-representation of Aboriginal and Torres Strait Islander people in WA's justice system; to transform old systems and prioritise smart justice, healthy families, and safe communities.

Raise the Age WA Campaign

Reconciliation WA is a firm supporter of the Raise the Age WA campaign, run by Social Reinvestment WA in collaboration with Change the Record.

The campaign advocates for the Age of Criminal Responsibility to raise from 10 to at least 14. Everybody wants their children to thrive, and no child should be sent far away from their family, community, and culture. Instead, we should be supporting them.

This year, Social Reinvestment WA developed a comprehensive evidence-based blueprint outlining a vision for a more effective, and connected youth justice system in Western Australia.

The report outlines a whole-of-system approach that responds to the underlying causes of offending to reduce crime, ensures the wellbeing of children and young people, and delivers safer and better futures for Aboriginal communities.

Farewell to Fred Chaney

At the 2021 Annual General Meeting, we said farewell to Fred Chaney AO, as he retired from the Reconciliation WA Board.

Fred's commitment to social justice, and his belief in the equal value of all people, has driven a long and passionate career in advancing the reconciliation movement in Australia. Following his service as Federal Minister for Aboriginal Affairs between 1978 and 1980, Fred was the inaugural non-Indigenous Co-Chair of Reconciliation Australia, where he served 15 years on the national body's board, five of which as Co-Chair.

Locally, Fred was part of establishing the Aboriginal Legal Service of Western Australia and was instrumental in establishing the Graham (Polly) Farmer Foundation, which supports Indigenous young people to reach their potential.

Fred was appointed an Officer of the Order of Australia (AO) in 1997 for his service to the Aboriginal community and in 2014 was named the Senior Australian of the Year for his contribution to indigenous reconciliation and human rights.

An inaugural Board member of Reconciliation WA, Fred served on the Board from its incorporation in 2015, providing wise and experienced counsel.

We are indebted to his contribution to the Reconciliation WA Board, to which he brought great insight, intelligence and humility to our deliberations.


